“According to Section 201-8 of the Education Law, petitions shall be filed thirty (30) days prior to April 20, 2010 which is on or before March 22, 2010 and each petition shall be signed by at least twenty-five (25) qualified voters of the School District, or 2% of the voters who voted in the previous election, whichever is greater, in order for a candidate’s name to appear on the ballot for this election.”
